With reference to above cited subject, I am directed to communicate that as per Academic Council Resolution No. 46/2022 dated 20/09/2022 and as per your proposal of Continuation of Affiliation/Extension of Affiliation, the Academic Council has unanimously resolved to grant Continuation of Affiliation / Extension of Affiliation for Academic Year 2022-2023 as per the provision u/s 68 and 65 (4) of MUHS Act 1998, for the Ayurved and Unani (Under Graduate) B.U.M.S. course of your college.

- The intake capacity of students shall be 50
- Grant of permission from NCISM /State Government (as applicable).
- Fulfillment of following deficiencies shall be strictly complied within 3 months, without fail

a. The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (format attached).

b. Those UG / PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the College to apply to the Central Council through Central Govt. and ensure that Permitted / Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

In view of above, I am directed to inform you that this is provisional affiliation to your college and as such you are requested to comply with the above mentioned deficiencies within the stipulated time without fail and submit compliance report. Compliance report will be verified by the University by re-inspection of your college.

Important Note:

- 1) This Continuation / Extension of affiliation is issued for the A.Y. 2022-2023 subject to the permission of NCISM/ Govt. of India / Department of AYUSH, New Delhi and if the permission is declined by the said authorities, this Continuation / Extension of Affiliation will be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the NCISM / Govt. of India/ Department of AYUSH New Delhi.
- 2) The admission shall be done through the Competent Authorities only.

Sub: Grant of Conditional Permission to Yunus Fazlani Unani Medical College and Al-Fazlani Unani Hospital, Kunjkhedha-431103, Maharashtra (Inst. ID UNI0315) with 50 seats in UG (BUMS) course for the academic session 2022-23 under section 28 of NCISM Act, 2020 and relevant regulations thereunder-regarding.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under.

Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

1. Further, to assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely **Yunus Fazlani Unani Medical College and Al-Fazlani Unani Hospital, Kunjkhedha, Maharashtra** inspection of your College was conducted on **15.09.2022 and 16.09.2022 via virtual mode** as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process **the conditional permission with 50 seats in UG (BUMS) course for the academic session 2022-23 under Section 28 of NCISM Act 2020.**
2. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Unani Colleges and attached Hospitals) Regulations, 2016" and provisions under the NCISM Act, 2020 and relevant Regulations there under, and on the basis of Relaxation policy issued by the NCISM dated 16.03.2022.
3. As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the **24th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **16.12.2022**. On careful examination of the assessment report it is found that **your college is fulfilling the notified & approved criteria, hence the Board decided to issue the Conditional Permission with 50 seats in UG (BUMS) course for the academic session 2022-23.**
4. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine to **grant conditional permission to Yunus Fazlani Unani Medical College and Al-Fazlani Unani Hospital, Kunjkhedha, Maharashtra with 50 seats in UG (BUMS) course for the academic session 2022-23 under section 28 of NCISM Act, 2020** subject to the condition that college is fulfilling the following requirements:-

- i. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
 - ii. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 50 UG (BUMS) seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2022-23 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
 - iii. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref. no. BUSS/Fec/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
5. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
 6. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
 7. **The following requirements should be fulfilled by the college by 31st December, 2022 and compliance report should be sent to get permission for the session 2023-24:**
 - i) all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Unani Colleges and attached Hospitals) Regulations, 2016;
 - ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Unani); and
 - iii) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto;
 8. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission from the academic session 2023-24.
